

## **Consultant- Medical Oncology**

Set up at a cost of Rs. 350 crores, the Hospital, with a capacity of 183 beds, serves all sections of the society, with 50% of the infrastructure earmarked for free or subsidized treatment for the underprivileged sections. Tata Medical Center is currently in an expansion mode with another 254 beds being added to the current bed strength. The hospital provides a wide spectrum of services from diagnosis, therapy to rehabilitation and palliative support in cancer.
